

RECKLESS IMPRUDENCE RESULTING IN DAMAGE TO PROPERTY WITH HOMICIDE

INFORMATION

The undersigned accuses DANIEL ESPINOSA Y OYANIN and VICTOR ANCHETA Y LOBOSITA of the crime of Reckless Imprudence Resulting in Damage to Property with Homicide, committed as follows:

That on or about the 13th day of May, 2011, in Quezon City, Philippines, Accused, VICTOR ANCHETA Y LOBOSITA, being then the driver and/or person in charge of a NOVA Bus bearing Plate No. TXE-271(owned by Nova Auto Transport Bus) and Accused DANIEL ESPINOSA Y OYANIN, being the driver and/or person in charge of a Daewoo Passenger Bus (owned by Universal Guiding Star Bus Line Corp.) with Plate No. UVC-343, did then and there unlawfully and feloniously drive, manage and operate their respective vehicle along Commonwealth Avenue, Diliman, this City, in a reckless, careless, negligent and imprudent manner, by then and there making their vehicles run at a speed greater than was reasonable and proper and without taking the necessary precaution to avoid accident to persons and damage to property considering the condition of the traffic on said place at that time, and as a consequence of their carelessness, negligence, imprudence and tack of the Nova Bus being driven, managed and operated by Accused precaution. Victor Ancheta hit and bump the right side portion of a Toyota Vios (Abu Abbey Taxi) bearing Plate No. TXH-532, driven and managed by VITO JAGUNOS Y TAMPOY and registered to Delfin B. Llagas, and then immediately thereafter, the Daewoo Passenger Bus being driven, managed and operated by accused Daniel Espinosa y Oyanin also hit and rammed the rear portion of the said taxi, thereby causing damages thereto in the amount of Php250,000.00, Philippine as a consequence of the strong impact, one LOURDES Currency; and, SIMBULAN Y ESTELLA, a passenger of the taxi, sustained serious and mortal wounds which were the direct and immediate cause of her untimely death; to the damage and prejudice of Mr. Delfin Llagas, owner of the said taxi and the heirs of Lourdes Simbulan y Estella.

That, immediately after the collision, both accused run away and failed to lend on the spot to the injured victim such help as maybe in their hands to give nor did they report the incident to the proper authorities outright for investigation; thus, the attendant circumstance of "failure to lend help to one's victim" under the last paragraph of Article 365 of the Revised Penal Code was present.
