URGENT MANIFESTATION AND MOTION

Petitioners, by counsel, and unto this Honorable Court, respectfully state that:

- 1. On April 1, 2009, Petitioners brought before this Honorable Court the instant Petition for Certiorari and Prohibition questioning the constitutionality of the new Philippine baselines law, Republic Act No.9 9522, otherwise known as "An Act to Amend Certain Provisions of Republic Act No. 3046, as amended by Republic Act No. 5446, to Define the Archipelagic Baselines of the Philippines, and for Other Purposes."
- 2. The Petition asks of this Honorable Court, pending action the resolution of the main issues presented, to enjoin Respondents and all persons acting for or in their behalf, room implementing Republic Act 9522, because since its implementation would clearly result in palpable violations of the Constitution to the extreme prejudice not only of Petitioners, but above all, of the Filipino people.
- 3. Indeed, unless the implementation of Republic Act 9522 is enjoined, the Permanent Representative to the United Nations in New York City, Hon. Hilario Davide, Jr., will deposit and register with the Secretary General of the United Nations (a) Republic Act

9522, and (b) the geographic coordinates and the charts and maps indicating the baselines defined by Republic Act. 9522, in accordance with Section 4 of the assailed law.

- 4. The registration and deposit of Republic Act 9522 and other related documents before the UN Secretary-General will forever close the door to any Philippine efforts to obtain the acceptance by the international community of our Constitutionally-defined national territory.
- 5. More importantly, the registration and deposit of R.A. 9522 before the UN Secretary-General, will immediately bind the Philippines to the UNCLOS III regime, leading to the dismemberment of the Philippine national territory as defined in the 1987 Constitution.
- 6. Hence, if the implementation of Republic Act 9522 is not immediately enjoined, Petitioners and millions of Filipinos will suffer great or irreparable injury before the matter can be heard by the Honorable Court. Thus, Petitioners respectfully ask the Honorable Court to immediately enjoin the implementation of Republic Act 9522, pending the resolution of this petition.

- 7. Today, Petitioners learned that a delegation of officials from Respondent offices the Department of Foreign Affairs, the National Resource Mapping and Information Authority (NAMRIA) and the Department of Budget and Management (DBM) are scheduled to fly to the United Nations Headquarters in New York, the United States of America on Sunday, April 5, 2009, to register and deposit the new Philippine baselines law, among other things.
- 8. Petitioners learned that an official delegation led by the head of the DFA's Center for Maritime and Ocean Affairs, lawyer Henry Bersuto Jr., is due to leave Manila for the UN headquarters in New York on the said date.
- 9. For this reason, Petitioners make this manifestation and reiterate their earlier prayer that Pending the resolution of this Petition, a Temporary Restraining Order and/or Writ of Preliminary Prohibitory Injunction be immediately issued, prohibiting Respondents from implementing or invoking Republic Act 9522.

PRAYER

WHEREFORE, Petitioners respectfully pray that this

Honorable Court take due notice of this Manifestation and, Pending

the resolution of this Petition, it IMMEDIATELY ISSUE a Temporary

Restraining Order and/or Writ of Preliminary Prohibitory Injunction

prohibiting Respondents from implementing or invoking Republic

Act 9522.
